Insolvency

Recent matters include:

Regularly acting for HMRC in the winding up petition list in the Business and Property Courts.

Bell v Ide [2020] EWHC 230 (Ch) - instructed by the Fourth and Fifth Respondents at first instance and on appeal to the Court of Appeal (unled; listed October 2020) in an application to strike out an originating application by trustees in bankruptcy because of late service of that application.

Re Inspired Asset Management Limited (In Administration) [2019] 3301 (Ch) - acted on behalf of administrators in an application seeking a power to remove and appoint directors of wholly-owned subsidiary SPVs.
